The contracting requirements include:

- Demonstration of Financial Stability or Request for a Waiver
- Signed BAA
- Submission of W-9
- Completion of HIT Survey
- Completion of Project Impact Matrix
- Signed Master Participation Agreement

Human Service Value Proposition Focus of AHI Summit Session

Heidi Milch, LMSW, Executive Director of Community Connections of New York, Inc., and PIE Analytics, Inc., will present, *What's In a Human Service Value Proposition?*, the first of a two-part program for leaders of community-based organizations at the AHI Summit on September 29 at The High Peaks Resort in Lake Placid.

In today's changing environment, organizations need to define, measure, and present the clear benefit they bring to the table. To help organizations position themselves for value based payment arrangements, the PPS is offering this session to introduce the concept of human service organization value propositions, customer and audience differentiation, and the role of data and measurement in value.

During this session, attendees will:

- Understand what a value proposition is and why it is needed;
- Understand different customer bases and the relationship to the agency's value proposition;
- Identify value from different perspectives; and,
- Learn the different types of data collection and understand the relationship between data and the value proposition.

The second session, *Developing a Value Proposition for Human Service Agencies*, will be held in November. In this hands-on workshop, facilitators will coach participants through the development of draft value propositions using tools and exercises that can be replicated throughout their agencies. Detailed learning objectives will be highlighted at the Summit session on September 29.

Innovation Fund Timeline Revised

The AHI PPS has allocated \$5.2 million over the span of the DSRIP program to support projects that represent innovative approaches to the design, delivery, and/or payment models for health care and social and community-based services in the areas of prevention, wellness, and those that impact the social determinants of health. The timeline announced previously has been modified. The RFP will be released later this month and awards will be announced in January 2017 for DSRIP Year 2.

Clinical Depression Screening and Follow-up Quality Measure

Effective documentation is a key to success in care management and improved patient health outcomes. There are three PPS projects with a quality metric related to Clinical Depression Screening and Follow-up on which the PPS is being measured.

The Screening for Clinical Depression and Follow-up quality measure applies to the following projects:

- Project 3.a.i “Integration of Behavioral Health with Primary Care”
- Project 3.a.ii “Crisis Stabilization”
- Project 3.a.iv “Withdrawal Management”

The AHI PPS scored 14.4% in measurement year 1. The DSRIP goal is 56.2%. “There is a significant opportunity to improve performance in this measure just by improved documentation,” said RuthAnn Craven, Practice Transformation Manager, AHI. “Often, physicians document a ‘positive’ for depression, but do not document the follow-up care indicating the patient was referred out and received treatment.”

Depression screening should be billed with one of two G-codes. For more detail regarding the HCPCS code and medical record documentation read [Clinical Depression Screening and Follow-up Quality Measures](#).
