Value Based Payment Survey Reminder

As mentioned in last week's edition of *DSRIP News*, one of the goals of the DSRIP program is to develop the infrastructure for a successful transition to a Value Based Payment (VBP) model.

To that end, we recently emailed the main contact at each AHI PPS Partner organization a link to a Value Based Payment survey. The survey must be completed by every Partner, regardless of VBP participation.

Certificate of Need for the Capital Restructuring Financing Program

On March 4, the NYS DOH notified organizations of awards received based on the grant application submitted to the Capital Restructuring Financing Program (CRFP) RFA #15-04100252.

These award letters had an enclosed addendum. In that addendum, the Department of Health stated all CON applications, if required, must be submitted to the Office of Primary Care and Health Systems Management for review within 180 days of receipt of the letter and must be contingently approved within 365 days of receipt of the letter. The 180 day deadline is August 31, 2016.

As stated in the addendum to your award letter, the DOH cannot execute your grant contract or reimburse you for any incurred costs associated with your project without CON approval, if required. In order to avoid any subsequent delays, we respectfully ask that you contact the DOH to begin this process.

- If you have reasonable assurance that no CON is required for your project or the DOH has already confirmed this for you, then please ignore this message.
- If you need an extension to the August 31, 2016 deadline and have not otherwise received one, please submit a request to CRFP@health.ny.gov. Please supply detailed information regarding your project and the need for an extension, the anticipated date you expect to file the CON, and include CRFP-CON in the subject line as well as the project number referenced in your grant award letter.
- If you have any questions regarding the need for a CON for your specific project or how to file it, please email CRFP@health.ny.gov. Please indicate CRFP-CON Question in the subject line, and provide the contract number and specific details regarding your project and question.
- If you have already filed a CON, please email CRFP@health.ny.gov with the CON number(s) assigned to each project under your award.

NEW! Workforce Training Assessments

The AHI PPS Training and Resources Workgroup has developed an assessment form for all trainings approved for funding by the workgroup. The DSRIP Training Assessment tool will assist the workgroup in planning future trainings – whether it's sharing information on a training that may be useful for other organizations, or investigating bringing a training program to our region. Level of Care for Alcohol and Drug Treatment Referral

The New York State Office of Alcoholism and Substance Abuse Services (OASAS) requires the use of Level of Care for Alcohol and Drug Treatment Referral (LOCADTR) 3.0, a web-based tool used by referral sources, as the criteria for determining medical necessity for substance use disorder for dates of service on or after July 1.
